



4. \_\_\_\_\_ is hereby assigned exclusively as the sole investigative agency, firm or individual authorized to locate and/or apprehend the said Defendant. All previously entered contracts with other firms, agencies, or individuals concerning the location and/or apprehension of the said Defendant have been terminated.
5. This agreement is based on full disclosure by the Client of any and all information available and known about the Defendant including all bonds posted on behalf to the said Defendant and all funds recoverable as a result of the location and/or apprehension of the said Defendant in any jurisdiction.
6. \_\_\_\_\_ reserves and claims the right to any and all rewards offered by private individuals, law enforcement and government entities in any location and in any jurisdiction in addition to the fees agreed upon on the document.
7. Since the agreed contact fee is based upon percentages of face values of bonds posted, any additional bonds not disclosed whether intentionally or unintentionally by the Bail Agent, Surety Agent, General Agent or Surety Insurance Company, active or forfeited which the Bail Agent, Surety Agent, General Agent or Surety Insurance Company may discharge liability or recover losses, paid forfeitures or obtain refund of payment of bonds shall automatically be included in the contract for services and are payable at the same rate and due accordingly.
8. Client agrees to pay \_\_\_\_\_ a \$100.00 non-refundable case preparation and processing fee at the time of assignment and acceptance of said case.
9. Client agrees that if the said Defendant is found incarcerated on the above charge(s) or any other charge(s) in ANY jurisdiction, the agreed location fee shall be paid to \_\_\_\_\_.
10. Client agrees that if the Defendant is apprehended by any law enforcement Agency while assisting or working in conjunction with Agents of \_\_\_\_\_ or as a result of information provided by Agents or Sub-Agents of \_\_\_\_\_ or removed from the custody of Agents of Company, Surety Agent, General Agent or Surety Insurance Company, or the Defendant surrenders himself to any of the above listed individuals, agents or agencies, the location fee and apprehension fee shall be payable.
11. Client authorizes \_\_\_\_\_ to act as exclusive agent for a period of ninety (90) days. This contract is automatically renewed at the end of 90 days unless \_\_\_\_\_ is specifically notified in writing by certified mail and least 15 days prior to expiration.
12. Client agrees to verify capias, warrant or bench warrants or court orders for arrest of the individual by the Surety or Bonding agent at any time requested by \_\_\_\_\_.
13. Client agrees to notify \_\_\_\_\_ in writing by certified mail immediately upon notification by any individual, firm or law enforcement entity that the said Defendant is in custody in any jurisdiction, or that a case has been closed by the court, or capias, warrant, bench warrant or order of arrest has been served or canceled at which time \_\_\_\_\_ will be paid the agreed upon location fee.

14. Client has the legal right to assign powers of arrest to \_\_\_\_\_ , its agents, and sub-agents and agree to hold them harmless from and against every and all claim, demand, liability, cost, charge, counsel fee, expense, suit order, judgment or adjudication whatsoever.

15. Client agrees that the payment due under this contract shall be due within 24 hours of the compensation event (location of Defendant, arrest of Defendant, etc.). Should said payment not be timely made there shall be assessed a late penalty equal to \_\_\_\_\_% of the compensation due. There shall be a like penalty accrue in equal amount for each day thereafter that the contacted compensation remains unpaid.

Client agrees that if \_\_\_\_\_ has to take any action to enforce the terms of this contact for Professional Services then in addition to any other relief, \_\_\_\_\_ shall be entitled to recover and Client agrees to pay all reasonable costs of collection, including but not limited to: reimbursement for man hours at normal compensation rates, long distance phone calls, FAX costs, copies, postage, investigation expenses and reasonable attorney fees, whether suit is filed or not.
